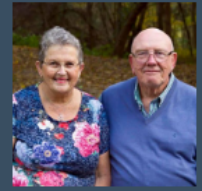


**Ruthann Voss**

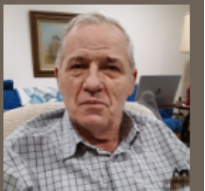


**Sam Mulder**
